



SELECTBOARD MEETING OF April 5, 2010

Meeting was called to order at 6:00PM in the Tegu Building Community Meeting Room by Brian Kellogg, Chair.

**I. Agenda Changes, Announcements & Additions**

1. Add open sealed bids for new truck body

**II. NEW BUSINESS**

1. **Speeding on River Street-** Richard Keith stated that this was an ongoing neighborhood dispute regarding a couple of teenage boys speeding, and spinning their tires. The Road itself is only about 150ft long, so excessive speed is unlikely, however they do respond to ever call and complaint.
2. **Paving Bids-** We received 3 bids; Asphalt Solutions \$98,800, Pike Industries \$98,781, A.C. Paving \$100,210 for paving Morrystown Corners Rd. The budget for paving is \$100,000, Bob recommended going with Asphalt Solutions even though their bid was about \$19.00 more than the low bidder to keep business local.

3. **Conservation Commission-** Jim Pease would like to serve another 4 year term with the Conservation Commission.

4. **Financial Plan for Town Highways-** This is the annual financial plan from the State. We need to approve and sign.

5. **Request to use Town Roads for Fun Run-** Tracy Desrochers is organizing a fun run as a fundraiser for the Green Mountain Kids afterschool programs new building. The run will take

place on May 22, 2010 which is a Saturday. The route to be used will be Harrell, Street, Munson Ave, Industrial Park Drive and Rt. 15.

6. **Acting Town Administrator-** Dan is going to be away from April 26- May3 for vacation, he would like the Selectboard to appoint Richard Keith, Chief of Police as acting Town Administrator for that week.

7. **Zoning Administrator/Health Officer/Planning Assistant-** Dan would like to move this to Executive session for Personnel.
8. **Truck Bids-** received 4 bids for the Truck body, plow & sander system. Viking \$55,393.00, Tenco \$47,803.00, Atec \$ 57,984.00, & H.P Fairfield \$53,560.00. Selectboard discussed the bids received; they would like to keep their business local even though the price is a bit higher.

**Motion made by Bob Beeman, seconded by Todd Yando to accept bid from H.P. Fairfield for \$53,560 for the truck body, sander system and plow. Motion approved. (4/0)**
